

NEW ORDER FOR AN INTERNATIONAL PROJECT IN THE FIELD OF IMMERSIVE VENUES FOR A VALUE OF APPROXIMATELY €2.8 MILLION

Order for the supply of MOVER, compact low-frequency transducers for applications such as auditoriums, convention centres, concert halls and entertainment facilities

Scandicci (Firenze), 13 September, 2021 – Powersoft S.p.A. (the "Company" or "Powersoft"), a global technology leader in audio amplification, signal processing and transduction systems for the proaudio sector, listed on AIM Italia, announces that it has today received an order for the supply of MOVER, compact low-frequency transducers with direct/inertial transmission, from Irwin Seating Company ("Irwin"), an American company and world leader in the audience seating market for cinemas, auditoriums, arenas, performance centres, stadiums and places of worship.

Mover (Tactile Sound Transducer) is a technology patented by Powersoft, born in its Ideofarm ideas incubator, designed and developed for gaming seats, e-sports, industrial applications, water effects for swimming pools, fountains, tubs, and for all those who wish to add a new dimension to the listening experience, and more. It is a product designed for 4D cinemas, theme parks or locations with vibrating walls and floors, which through haptic perception, guarantees the audience a multisensory immersive experience.

This supply agreement, the value of which is estimated at approximately €2.8 million, is part of a broader project that envisages the development and production of innovative venue systems for shows and immersive performances; the supply is envisaged in several tranches starting from 2022, subject to the timing of the project.

"This supply", commented Luca Lastrucci, CEO of Powersoft, "confirms the validity of Powersoft's strategy, which has always invested in research, also through our Ideofarm incubator and ideas accelerator, for the development of innovative products and solutions. It is a demonstration of how Powersoft has been able to intercept an expanding market trend, laying the foundations for an acceleration towards the entertainment sector, for applications such as 4D cinema, theme parks and locations with vibrating floors". "This is an important sign of recovery, a confirmation of trust in the quality of our innovative solutions", continues Lastrucci, "and represents for the company a further step in the growth of sales in this type of application where spectators will be able to enjoy incredible and new experiences".
